TERMS AND CONDITIONS

• Once the exhibition space reservation has been confirmed, the location cannot be changed.

• No reservation will be processed without the payment of 100% of the total amount and sending of the bank receipt for this amount.

• Payment of 100% of the total amount must be made by bank transfer once the invoice has been received.

IMPORTANT:

• Exhibitors must **send the project for their space, specifying all the construction and installation details**, to be approved by the Ciclosfera organization to: jorge@ciclosfera.com and fernando@ciclosfera.com before April 1, 2025.

• It is an essential requirement that all the structures placed by the exhibitor in his space are **secured with a minimum of 8Kg in each of the legs**. If this is not the case, the organisers may take whatever measures they deem appropriate in each case. This includes the removal of the structure.

• Any situation, whether fortuitous or due to force majeure, that results in the cancellation of the event by the Ciclosfera 2025 organization or, if the exhibitor decides to cancel its participation in the fair for any reason, these will be the cancellation conditions:

- Between 1 and 28 February 2025, 100% of the amounts paid by exhibitors will be refunded.
- Between 1 and 15 March 2025, 50% of the amounts paid by exhibitors will be refunded.
- Between 16 March and 15 April 2025, 25% of the amounts paid by exhibitors will be refunded.
- Between 16 and 30 April 2025, no amount paid will be refunded at all.
